Australian Council for Health, Physical Education and Recreation (ACHPER) National Strategy (2014-2016) lists four strategic priorities, which includes; 'to identify and promote broader ACHPER collaborations and partnerships'. The International Council for Health, Physical Education, Recreation, Sport and Dance (ICHPER-SD) shares vision and purpose with ACHPER and PENZ (Physical Education New Zealand), specifically with an international focus. Hence, ACHPER, PENZ and ICHPER-SD, working in collaboration, compliment and strengthen one another in promoting active and healthy living, as evidenced throughout history.

The umbrella international organisation ICHPER was first conceived in 1950, and officially founded in Rome, Italy in 1958. The theme of the first ICHPER world congress was 'Child Health and the School'. There have since been 36 world congresses, 32 regional congresses and numerous forums, conferences and symposia. The ICHPER name was extended to include 'Sport' and 'Dance' (ICHPER-SD) in Yokohama, Japan in 1993. The latest congress, the 56th ICHPER-SD Anniversary World Congress & Exposition was recently held in Bahrain (December, 2014). ACHPER was formally known as Australian Physical Education Association (APEA) and the name change was a direct result of the ICHPER-SD first and only world congress to be held in Oceania (Sydney, 1970). Some may remember the ICHPER-SD (Oceania) first Regional congress, held in Wellington, NZ in 2006. The title of the 1970 Sydney world congress was 'New Endeavours in Physical Education, Health Education and Recreation', it was of international significance, the best attended conference in the history of APEA and a milestone for 'Health, Physical Education and Recreation' (Kirk & Macdonald, 1998). Proud ACHPER member and ICHPER-SD Vice-President (representing Oceania region), Dr. Timothy Lynch shares the strong history, direction and opportunity for working collaboratively with one of the oldest, largest and most prestigious international umbrella organisations.

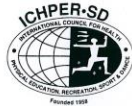
ICHPEReSD, with its limited geographical extension offset by numerous projects and activities spread across the region, is a longstanding partner of UNESCO. Admitted to former Category B in 1979 and former Category A in 1984, its co-operation in promoting physical education and sport is regarded as important by the Education Sector. It recently submitted a draft revision of the UNESCO charter on physical education adopted in 1978. Nonetheless, over the past 10 years, ICHPER.SD has not responded to the Director-General's consultations on preparing the C/5 and C/4 documents nor responded in time to preparation of the sexennial report on NGOs. I am writing in regards to a study that extends from the UNESCO-NWCPEA World wide Survey of School Physical Education.

Briefly, I am the Vice-President (representing Oceania) of the International Council for Health, Physical Education, Recreation, Sport and Dance (ICHPER-SD). I have attached my letter of introduction that I posted (air mail) to the UNESCO Headquarters in Paris, 12 months ago.

ICHPER-SD have a strong and proud history working in partnership with UNESCO (Please see Literature Review attached).

At the 56th ICHPER-SD Anniversary World Congress & Exposition held in Manama (Bahrain), December 18-20 2014, the Executive Committee discussed in great depth various research projects. These discussions will continue on March 17, 2015 at the ICHPER-SD Forum to be held in Seattle, Washington (US) in conjunction with the 130th SHAPE America (AAHPERD) Convention and Exposition.

One research project that ICHPER-SD are discussing relates to the World wide Survey of School Physical Education. The possible project will be in more depth. This link is to a report that I completed for the Australian Government [Australian Institute of Teachers and School Leaders (AITSL)] . It shares insights of how Physical Education is implemented in primary schools in Australia.

This study was specifically for Government primary schools (376 principal participants from a cross-section of Australian Government schools representing every state and territory, region and size). Data was also collected for Catholic Education Schools (making up 25% of schools in Australia) and Independent Schools. In total the study has approximately 700 surveys completed by school principals giving an accurate and detailed account of how PE is implemented in Australia. This extends from the 'UNESCO-NWCPEA World wide Survey of School Physical Education' which had 11 surveys completed for Oceania (Australia, New Zealand and the Pacific Islands).

ICHPER-SD are interested in extending this primary school survey across New Zealand and the Pacific Islands to represent Oceania. Also across all eight regions of ICHPER-SD; Africa, Asia, Caribbean, Europe, Latin America, Middle East, North America (& Oceania).

ICHPER-SD Fitness Research Project

- similar research projects within Australia recently that may provide valuable data.
- Dr. Richard (Dick) Telford - LOOK (Lifestyle Of Our Kids) project - longitudinal study; commenced in 2005 with 850 participants from 29 schools. Data (measurements) were collected annually from 8 - 12 years and in 2013 measurements were taken of the children at 16 years of age. Fitness was measured and details of methods are offered in the papers.
- Active Healthy Kids Australia (AHKA) Report Card which was released for the first time in 2014. Developed by a team consisting of 26 researchers and representing 12 Australian universities and research groups. The Report Card was “developed using synthesised data from a number of national and state-based surveys” (Active Healthy Kids Australia (AHKA), 2014, p. 6). The surveys were all conducted since 2008 and involved more than 33 000 participants (boys and girls) between the ages of 2 and 17 years. The 2014 AHKA Report Card assigns letter grades across 12 different indicators
- The magnitude of these projects are much larger than I could personally develop. I think that the best and most efficient way of providing the ICHPER-SD International Fitness Project with the data from Australia (Oceania) would be to use the data that has recently been published and/or invite Dr. Richard (Dick) Telford to become involved.

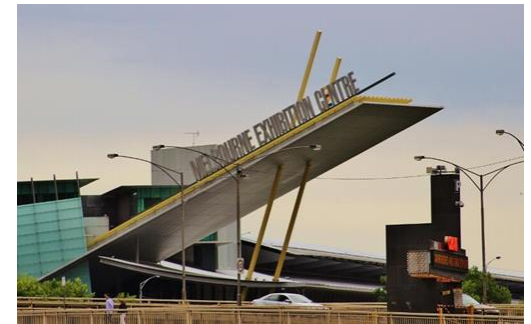

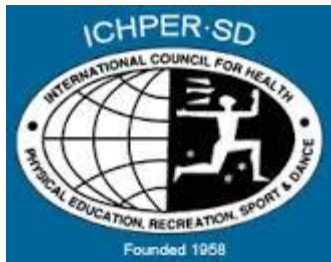
